

Child Marriage and Other Crimes against Children in Odisha


Child marriage (i.e., marriage of girls below the age of 18 and boys below the age of 21) in India is one of the most serious crimes committed against children. It is prevalent in most of the States/UTs despite a law (Prohibition of Child Marriage Act, 2006) to root it out. Child marriage ends childhood and puts children at high risk of violence, exploitation, and abuse. It also adversely impacts their rights to education, health and protection.

A total of 1,49,404 crimes against children were recorded in India in 2021, indicating an average of 409 such cases reported each day during the year. This included a total of 1,050 cases registered under the Prohibition of Child Marriage Act, victimising 1,062 children. Of all the registered crimes against children across the country in 2021, a little more than 5 percent were from Odisha (7,899). The state stands at the 5th position, in terms of percentage share of the total crimes committed against children during 2021 in the country.



A comparison with last year's reported crimes in Odisha shows an almost 25 percent increase in the total number of crimes against children (from 6,330 in 2020). However, the number of victims of child marriage increased by 167 percent (from 24 in 2020 to 64 in 2021) as compared to the national average of 34 percent increase (from 792 victims in 2020).


Child Marriage

• During the last 3 years, there has been an increasing trend in the number of victims of child marriage in Odisha, from 22 in 2019 to 64 in 2021 (a 191% increase) (Figure-1).

- While there is a 3.5 percentage point decrease in women aged 20-24 years falling prey to child marriage between 2015-16 and 2019-21 (from 26.8% to 23.3%) in India, there has been a much lesser fall by 0.8 percentage points in Odisha (from 21.3% to 20.5%) during the same period.
- As per the Census 2011, in Odisha a little less than 2.6 lakh children were married off before
 the attainment of the legal age of marriage, which constituted approximately 2 percent of all
 married children in the country. However, NCRB data suggests that only 110 cases of child
 marriage were registered in the state under the Prohibition of Child Marriage Act during
 2019-21.
- Court disposal of cases under Prohibition of Child Marriage Act:
 - The conviction rate in child marriage cases in India is extremely poor at a mere 10 percent, the lowest conviction rate of all types of crimes committed against children. In 2019, 2020 and 2021 the number of cases which ended with conviction was only 12 (out of 1,640), 6 (out of 2,092) and 10 (out of 2,865) respectively.
 - At the end of 2021, a mounting 96 percent child marriage cases in the country were pending trial (2761 cases pending out of 2865 cases).

Teenage Pregnancy

Teenage pregnancy¹, which is primarily a consequence of child marriage, has come down from 7.9 percent in 2015-16 to 6.8 percent in 2019-21 at the all-India level. In Odisha, no change was detected across the two surveys (Figure-2).





Sexual Violence

• The total number of POCSO cases in the state increased by twenty three percent during 2019 to 2021 (from 2,036 in 2019 to 2,498 in 2021), as compared to a 14 percent increase (from 47,335 in 2019 to 53,874 in 2021) at the national level.

- The percentage share of child rape cases to the total POCSO cases stands at 62 percent at the national level in 2021. In Odisha, the same is considerably higher (75%) than the national average in 2021.
- Court disposal of POCSO cases:
 - The conviction in POCSO cases in terms of absolute numbers increased from 3,686 (out of 9,316 cases in which trial was completed) in 2020 to 5,156 (out of 15,989 cases in which trial was completed) in 2021.
 - In Odisha, only 35 POCSO cases reached conviction out of 223 cases in which trial was completed in 2020².
 - At the end of January 2022, a total of 2,26,728 POCSO cases were pending trial in the country, of which 12,332 cases were from Odisha³.



Child Trafficking

- In Odisha, of the total victims of trafficking, 34 percent (497 out of 1,475) were children as compared to 44 percent (2,877 out of 6,533) at the national level in 2021.
- The total number of victims of child trafficking in Odisha increased from 202 in 2019 (108 girls and 94

boys) to 497 (291 girls and 206 boys) in 2021 (increased by 146%). Girls constituted 59 percent of the total trafficked children in 2021.

Missing Children

• The total number of missing children in the state increased by 31 percent during 2019 to 2021 (from 3,151 in 2019 to 4,133 in 2021), as compared to a six percent increase at the all-India level (from 73,138 in 2019 to 77,535 in 2021).
