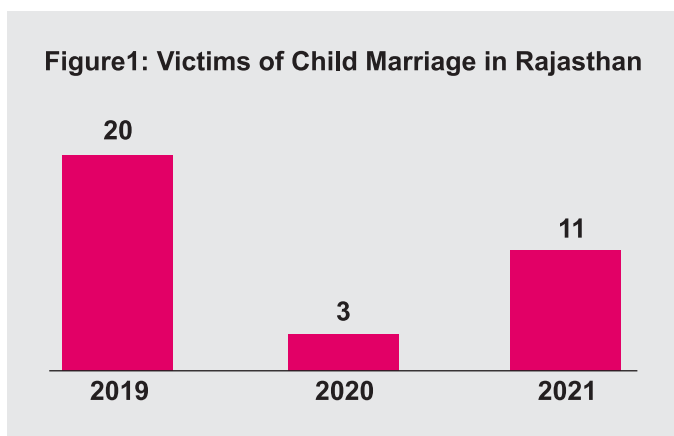


CHILD MARRIAGE AND OTHER CRIMES AGAINST CHILDREN IN RAJASTHAN

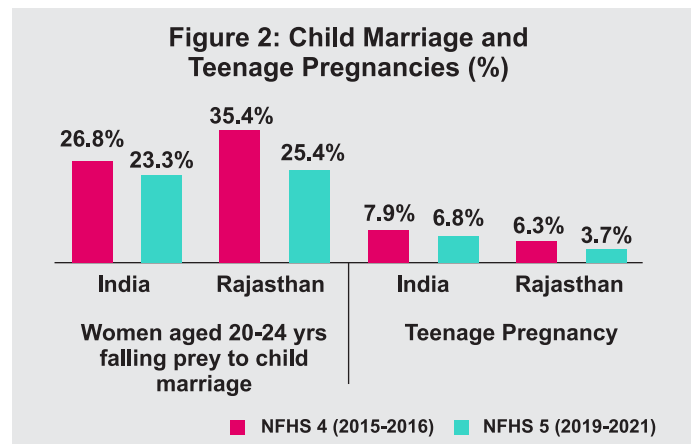
Child marriage (i.e., marriage of girls below the age of 18 and boys below the age of 21) in India is one of the most serious crimes committed against children. It is prevalent in most of the States/UTs despite a law (Prohibition of Child Marriage Act, 2006) to root it out. Child marriage ends childhood and puts children at high risk of violence, exploitation, and abuse. It also adversely impacts their rights to education, health and protection.

A total of 1,49,404 crimes against children were recorded in India in 2021, indicating an average of 409 such cases reported each day during the year. This included a total of 1,050 cases registered under the Prohibition of Child Marriage Act, victimising 1,062 children. Of all the registered crimes against children across the country in 2021, about 5 percent were from Rajasthan(7,653). The state stands at the 6th position, in terms of percentage share of the total crimes committed against children during 2021 in the country.

A comparison with last year's reported crimes in Rajasthan shows a 16 percent increase in the total number of crimes against children (from 6,580 in 2020). The number of victims child marriage also increased from 3 in 2020 to 11 in 2021 as compared to the national average of 34 percent increase (from 792 victims in 2020).



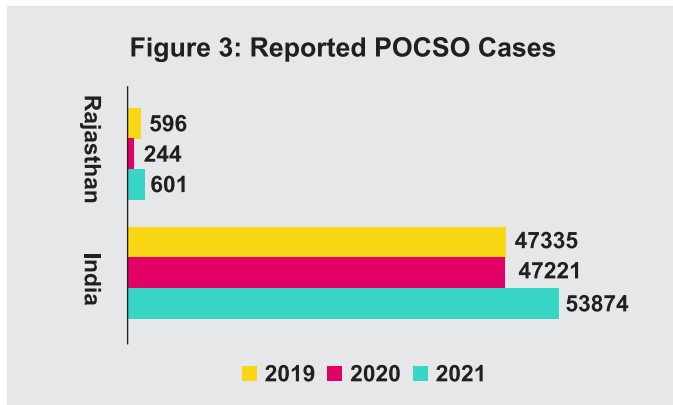

Child Marriage

- During the last 3 years, there has been a continuous fluctuating trend in victims of child marriage in Rajasthan, from 20 in 2019 to 3 in 2020 to 11 in 2021 (Figure-1).
- As against a 3.5 percentage point decrease in women aged 20-24 years falling prey to child marriage between 2015-16 and 2019-21 (from 26.8% to 23.3%) in India, the comparative decrease in Rajasthan is 10 percent (from 35.4% to 25.4%) during the same period.
- As per the Census 2011, in Rajasthan 12.9 lakh children were married off before the attainment of the legal age of marriage, which constituted approximately 11 percent of all married children in the country. However, NCRB data suggests that cases of only 34 children were registered in the state under the Prohibition of Child Marriage Act during 2019-21.
- Court disposal of cases under Prohibition of Child Marriage Act:
 - The conviction rate in child marriage cases in India is extremely poor at a mere 10 percent, the lowest conviction rate of all types of crimes committed against children. In 2019, 2020 and 2021 the number of cases which ended with conviction was only 12 (out of 1,640), 6 (out of 2,092) and 10 (out of 2,865) respectively.
 - At the end of 2021, a mounting 96 percent child marriage cases in the country were pending trial (2,761 cases pending out of 2,865 cases).

Teenage Pregnancy

Teenage pregnancy¹, which is primarily a consequence of child marriage, has come down from 7.9 percent in 2015-16 to 6.8 percent in 2019-21 at the all-India level. The corresponding decrease in Rajasthan has been from 6.3 percent to 3.7 percent (Figure-2).

Sexual Violence

- The total number of POCSO cases in the state almost remained constant during 2019 to 2021 (changed from 596 in 2019 to 601 in 2021), as compared to a 14 percent increase (from 47,335 in 2019 to 53,874 in 2021) at the national level.
- The percentage share of child rape cases to the total POCSO cases stands at 62 percent at the national level in 2021. In Rajasthan, the same is negligible as only 1 case of child rape was reported in 2021.
- Court disposal of POCSO cases:
 - The conviction in POCSO cases in terms of absolute numbers increased from 3,686 (out of 9,316 cases in which trial was completed) in 2020 to 5,156 (out of 15,989 cases in which trial was completed) in 2021.

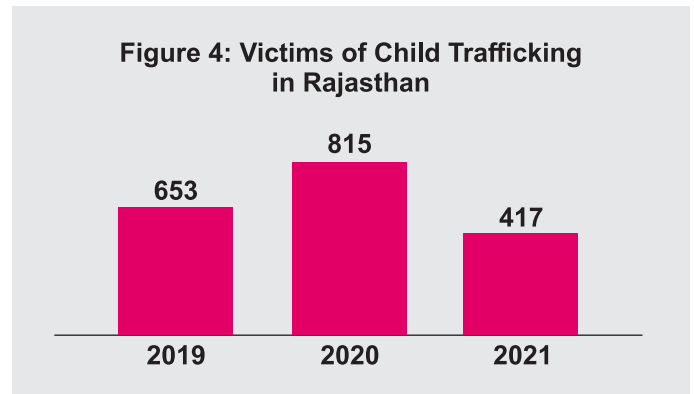

- In Rajasthan, 302 POCSO cases reached conviction out of 371 cases in which trial was completed in 2020².
- At the end of January 2022, a total of 2,26,728 POCSO cases were pending trial in the country, of which 8,573 cases were from Rajasthan³.

Child Trafficking

- In Rajasthan, of the total victims of trafficking, 99 percent (417 out of 420) were children as compared to 44 percent (2,877 out of 6,533) at the national level in 2021.
- The total number of victims of child trafficking in Rajasthan decreased from 653 in 2019 (17 girls and 636 boys) to 417 (22 girls and 395 boys) in 2021 (decreased by 36%). Girls constituted 5 percent of the total trafficked children in 2021 as against the national average of 45 percent.

Missing Children

- The total number of missing children in the state increased by 35 percent during 2019 to 2021 (from 3,655 in 2019 to 4,936 in 2021), as compared to a six percent increase at the all-India level (from 73,138 in 2019 to 77,535 in 2021).
